What Is Considered a Lewd Act On a Child?

A person who commits a lewd act upon a child or uses the body or a member or part of the body of a minor child under the age of 16 to commit such an act is guilty of a felony in Idaho. Under Idaho Code 18-1508, a lascivious or lewd act includes one or more forms of the following actions or others:

- manual-genital contact
- oral-genital contact
- genital-genital contact
- manual-anal contact
- oral-anal contact

- anal-genital contact

When Does the Lewd Conduct Law Apply?

A person who commits any of the sexual acts listed above and does so with the intention of appealing to, or arousing, or gratifying his or her own passions, lust, or sexual desires is guilty of lewd conduct. Or, if the person commits one of those acts with the intent to excite any of the above-described sensations in the child, or in any other person, he or she is guilty of lewd conduct, a felony sex crime in Idaho.

Who Is Affected By the Lewd Conduct Law in Idaho?

The law in question applies to a person who commits one of the sexual acts listed above, whether it involves persons of the opposite or same sex. It also applies to someone who involves a child under age 16 in bestiality or an act of sado-masochism as described under Idaho Code 18-1507. An individual perpetrating such an act as one of these is guilty of a felony sex crime against a child in Idaho.

Punishments for Lewd Conduct With a Child

A person convicted of the crime of Lewd Conduct with a minor shall be imprisoned in the Idaho state prison system for a term of up to life.
